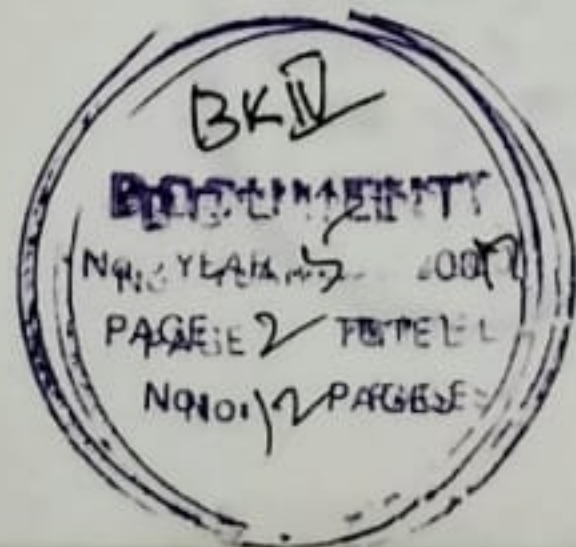
Declaration:



OBJECT OF THE TRUST

1. To establish, maintain, run, develop, improve, extend, takeover, acquire, grant donation for, and to aid and assist in establishment, maintenance, running, development, improvement, taking over, acquisition and extension of Elementary schools, secondary schools, Matriculation Schools, CBSE Schools, High Schools, Higher Secondary Schools, Polytechnics, Colleges and all kinds of educational Institutions and hostels for the benwfit of the Students.

2. To institute and award scholarship including loan scholarships without interest and stipends to the students for the purpose of education.
3. To provide assistance in cash or in kind to poor and deserving students to complete their studies.
4. To open and run residential and non-residential educational institutions in rural areas in accordance with the rules and regulations of the Government, wherever such rules are prescribed.
5. To open and run schools for the blind, deaf, dumb and mentally retarded and other physically disabled students.
6. To construct buildings and structures of whatever nature or kind as are found to be necessary or expedient and to demolish, alter, repair, renovate, improve, extent, develop the buildings or part thereof in furtherance of the objects of the Trust.
7. To purchase, to exchange or to take on lease and license or on hire or otherwise deal with any movable property the trustees may deem necessary for the furtherance of the objects of the Trust.
8. To sell, exchange, alienate, lease, mortgage, charge, transfer, hypothecate, surrender, dispose off and / or otherwise deal with all or any of the property and assets of the Trust for the benefit of the Trust.
9. To apply for, receive, accept and utilize the grants from Government, University and other non-Governmental agencies, Societies, Associations and Institutions.
10. To receive, accept, charge from students, trainees, boarders such fees and charges as prescribed and normally received.

11. To Open and Operate bank accounts in the name of the Trust in Scheduled and/or nationalised banks on such terms and Conditions as the trustees may deem fit.
12. To borrow money from banks, third parties on Security of any of the Properties of the Trust for the benefit of the Trust.

#### RULES AND REGULATIONS

The Trust hereby Constituted shall be known as **MATHIKUMAR EDUCATIONAL TRUST**.


The office of the Trust shall be Situated **Rental Building at No. 11-2-37A, Velu Servai Building, Madurai Road, Thiruppathur Town, Thiruppathur Taluk, Sivagangai Dist.**

Pin No. 630 211 the trustees under Specific direction from the Founder may Change the Situation of the Office of the Trust.

The TRUST FUND Shall Consist of the Said sum of **Rs.1000/-** which the Founder has Contributed to the Trust by Delivering it to the TRUSTEES and shall include all other properties and investment of any kind whatsoever into which the same or any part thereof may be Converted, invested or Varied from time to time and those which may be acquired by the Trustees from whatsoever Sources and which come to their hand by Virtue of these presents or by operations of law or otherwise whatsoever in relation to these presents including gifts and donation either in cash or kind or other properties movable or immovable or otherwise which may be received by the Trustees from time to time for the purpose of these presents.

The Trust Shall be governed by board of Trustees and the number of Trustees in the board shall not be less than two and shall not more than Six. The First board or Trustees shall Comprise of THREE Permanent Life Time Trustees, They are:

- i) **V.GNANAPANDIDHAN** S/o Sri. Velu aged about 47 years and residing at 331, Therendhalpatti Kottaiyiruppu – post Thiruppathur – Tk, Sivagangai Dist. Pon : 630211
- ii) **G.KALAISELVI** W/o Sri. Gnanapandidhan aged about 33 years and residing at 331, Therendhalpatti Kottaiyiruppu – post Thiruppathur – Tk, Sivagangai Dist. Pon : 630211
- iii) **S.ALAGU** S/o Sri. Shanmugam aged about 59 years and residing at 18/1, Muthumari Nagar 3 rd Cross, Gandhipuram 1 st Street V.O.C. Road, Karaikudi – 630001.

The Trustees for the time being shall have power to appoint Additional Trustees provided that the total number of Trustees shall not exceed Six.

Additional Trustees shall retire in every three years and shall be eligible for re-appointment.

A Trustee may resign from his/her office of Trustee of these presents by giving not less than one month notice in writing to other trustees for the time being.

No person shall be eligible to be appointed as a trustee and a trustee shall cease to hold the office of trustee if

- He/she is or becomes a person of unsound mind
- He/she has been or is convicted of an offence involving moral turpitude
- He/she has been or is adjudged insolvent
- He/she is suffering from bodily infirmity which shall render him/her unfit for active Work.

The Meeting of the Board of Trustees shall be held at least once in three months and the proceedings shall be recorded in the minutes book separately kept for this purpose.

If for any reason in the event of dissolution of the trust, the funds and the properties belonging to the trust shall be transferred and handed over to any other charitable trust or institution or society, whose aims and objects are similar or near similar to the object of this trust, which enjoys recognition under section 80 G of the Income Tax Act 1961 as decided by the Board.


The investments of the surplus of the trust will be made in accordance with the provisions of Sec 11 (5) read with Sec.13 (1) (d) of the Income Tax Act, 1961

The trust is irrevocable.

Any amendment to the Trust deed which may prove repugnant to the provision of sections 2(15), 11 to 13 and 80G of the Income Tax Act 1961, as amended from time to time, after registration under Income tax Act, 1961, shall be carried out only with the prior approval of the commissioner of Income tax.

The financial year of the Trust shall be from 1s April to 31<sup>st</sup> March of the following year.

The benefits of the Trust are open to all irrespective of caste/religion , region, ethnicity or gender.


